Terms and Conditions

- There is no term in this application.
- The vendor agrees to carry liability insurance and possess all applicable licenses. The vendor agrees to provide documentation of their current license(s) and insurance to GNS.
- Vendor must certify that they, their owners, and their officers are not listed as disbarred, suspended or otherwise ineligible on the Federal Government's Excluded Parties List System (SAM.gov), and must notify GNS immediately if they become so listed.

- **GNS Clients are issued a wood voucher for one or two cords of firewood. GNS will pay \$350 per cord of wood delivered under this agreement.** This pricing will be reviewed on an annual basis or as market forces require.
- Clients who live more than a 60 mile round trip from major distribution centers will have supplemental delivery fees added to their voucher as a separate item. These fees are based on the Federal Mileage Reimbursement rate and the travel time required. They will be reviewed on an annual basis or as required.
- The entire voucher must be submitted for payment at once—partial voucher payments are not allowed.
- Wood needs to be delivered completely split and measured for accuracy.
- The wood should be dry and ready to burn.
- The client must be informed of the type of wood you can provide, and you must deliver the type of wood you agree to bring.
- We advise our clients that most vendors do not do special cut sizing.

Compensation and Payment Schedule: Once you have made a delivery, please collect the GNS voucher from the client, complete and sign the voucher, and submit the voucher to GNS to receive payment. Vouchers can be submitted by mail or in person. Payments are made 60 days after receipt.

Current Supplemental Delivery Fees

These fees are based off the premise that the base cord price includes delivery within a 30 mile radius (or 60 mile roundtrip). The geographic center of the firewood vendors is roughly in Yreka, the County seat. Since supplemental delivery fees must be calculated before the voucher is issued and a vendor is arranged, distances and time were based off travel from Yreka.

Supplemental fees include a per mile fee and travel time at \$15/hour. Addresses in the areas listed above will use the standard fees in the table. Most clients in the Happy Camp area source their wood through a local vendor and there will not be delivery fees included. Those who do not will be dealt with on a case-by case basis.

Supplemental fees are not adjustable after a voucher has been issued.
